

COVID UPDATES

Attendee Health Attestation

To do our part in preventing the spread of COVID-19, we are restricting attendance at any of our Executive Council meetings from anyone with knowledge that they have a COVID-19 Infection or have recently been exposed to the virus.

If you cannot affirm or attest to any of the above on the day of the event, please do not attend. We will gladly provide you with a full refund. There is a risk of COVID-19 exposure in any public place where people are present. COVID-19 is highly contagious and can lead to illness and death.
