Andy turned the floor over to Erin Farrington Finlen, who gave the report. The Section's task force looked at what other states such as New York and California were doing in this area, but failed to consider Florida's unique size, circumstances, and demographics.

#### *IV.* <u>Liaison with Board of Governors Report</u> — Scott Westheimer

Scott Westheimer gave the following report from The Florida Bar Board of Governors ("BOG"). He noted that he is running for President of Florida Bar.

The Florida Bar Board of Governors held its hybrid meeting on October 1, 2021. The major actions of the Board included:

• The Board requested a <u>four-month extension</u> from the deadline the Supreme Court set to amend Bar Rule 3-5.2 to allow temporary suspensions of lawyers who face felony charges. In a June letter to the BOG, the justices cited a "continuing need to protect the public," and noted that the current Rule 3-7.2 127630256.2 only provides for suspensions after a determination of guilt has been made in a criminal case. The Disciplinary Procedure Committee asked the Board to seek more time to develop the rule after the Criminal Law Section expressed due process concerns and committed to providing an alternative proposal for consideration by December 1.

- The Special Committee for the Review of Professionalism in Florida, which is Co-chaired by President-Elect Gary Lesser and Elizabeth Hunter, reported that it is on track to deliver final recommendations to the Board by December. The committee was directed to review the Bar's professionalism standards, how they are taught to law students and lawyers and reinforced throughout a lawyer's career, and how they are enforced. The Special Committee established three subcommittees to address these issues: The Professionalism Education Subcommittee, Professionalism Standards Subcommittee and Professionalism Enforcement Subcommittee. The Professionalism Enforcement Subcommittee recently held a meeting with all Chairs from Local Professionalism Panels to address the efficacy of their local professionalism panels and the entire committee was set to meet on November 9th.
- The Board approved a recommendation developed by the COVID-19 Pandemic Recovery Task Force to ask the Supreme Court to consider a managed mediation program to address an expected flood of evictions. The recommendations are based on a 2009 report by a Florida Supreme Court task force that recommended a managed mediation program to address an avalanche of mortgage foreclosures that accompanied an economic downturn. The Task Force incorporated the concerns voiced by the RPPTL Section to ensure that any mediation take place at or before the hearing on possession is held.
- The Board of Governor's response to the Supreme Court on the final report of the Supreme Court's Special Committee to Improve Delivery of Legal Services is scheduled for a final vote on Monday, November 8<sup>th</sup>. The BOG received in excess of 300 comments from members, sections, voluntary bars and other organizations. The BOG appreciates these comments and the well thought out and comprehensive letter from the RPPTL Section on the report.

Jon Scuderi provided the Treasurer's Report. He noted the Section has made significant revenue from the virtual webinars as well as the Attorneys Trust Officer Conference.

Jon thanked the Budget Committee for its hard work. He then presented the proposed budget contained in the Agenda packet. Since the motion to approve came from the Budget Committee, it required no second.

The 2022-2023 budget was approved unanimously.

#### VII. Director of At-Large Members Report — Steven H. Mezer, Director

Steve Mezer recognized all of the lead ALMS. He noted the various initiatives and projects of the ALMS such as No Place Like Home. He also noted that Section members had logged 900 pro bono hours to Bay Area Legal Services alone.

Steve also noted that the deadline to apply or re-apply to be an ALM is December 15, 2021.

Bob recognized Joe Tschida of WFG and thanked them for sponsoring the Section App.

Sancha Brennan provided the report. She thanked the speakers and attendees for the CLE programs. Through September 2021, they have reached half of their budgeted goal for the year. She then recognized the Vice-Chairs for their hard work and noted the numerous CLE programs that are contained in the Section's library.

Sancha also thanked Mary Ann Obos and Hillary Stephens for their tireless work on behalf of the CLE Seminars and the Section. A well-deserved round of applause was given to Mary Ann and Hillary.

Brenda Ezell presented a Committee Motion to Amend the proposed legislation contained in the Agenda Packet to add the definition of business hours as being between 8:00 am - 5:00 pm, Monday through Friday.

The Motion to Amend was approved unanimously.

The following Motion was then made: Motion to (A) approve the creation of Florida Statutes Section 49.072 establishing a process to serve unknown parties in possession of real property; (B) find that such legislative position is within the purview of the RPPTL Section; and (C) expend Section funds in support of the proposed legislative position.

Since the Motion presented by Brenda Ezell was from the Real Estate Leasing Committee, it did not require a second.

The Motion was approved unanimously.

#### Information Item:

**1. Condominium and Planned Development Committee –** *Joseph E. Adams and Margaret "Peggy" A. Rolando, Co-Chairs* 

Bill Sklar gave a report on the subcommittee that was formed to study and give recommendations regarding the Sunrise Collapse. Bill Sklar chaired the task force, which was comprised of the following individuals:

William Sklar-Chair - Tallahassee Peter Dunbar - Tallahassee Ivette Blanch - Coral Gables Jose Rodriguez - Miami Christopher Davies - Naples Michael Gelfand - West Palm Beach Joseph Adams - Fort Myers, Ex Officio Margaret "Peggy" Rolando - Miami, Ex Officio

The task force delivered a 170-page report on October 12, 2021 to the Governor's office, the legislature, and others. The task force recommended that a maintenance protocol be adopted for all condominiums three stories and higher, and that they be inspected every 30 years, and then subsequently every 5 years. The report also recommends that reserves be established for the required maintenance and the engineering reports. The report was completed within 95 days. Bill thanked the Task Force for their very hard work.

Katherine then called on Len Prescott of First American Title as a sponsor. Len thanked the Section for allowing First American to sponsor the Section. He also noted that Jennifer Bloodworth, a Section member, was specially recognized by First American to attend a conference for women in the title industry in Laguna Beach, California.

John thanked the Florida Bar Foundation for its sponsorship of the Section.

#### Action Items:

#### 1. Trust Law Committee – Matt Triggs, Chair

Matt was unable to participate in the meeting due to unforeseen circumstances. John Moran presented the Trust Law Committee's motion as follows:

Proposed amendments to § 736.0705, Fla. Stat. to clarify that a trust instrument may, subject to minimum notice requirements, provide an additional method by which a trustee may resign.

Committee motion to:

provide an additional method by which a trustee may resign; and making clear that the options set forth in the statute are alternatives, each of which may operate exclusive of the others;

- (B) Find that such legislative position is within the purview of the RPPTL Section; and
- (C) Expend Section funds in support of the proposed legislative position.

Since the motion came from a Committee, a second was not required.

The Motion was approved unanimously.

#### Information Item:

1. Ad Hoc Committee on Electronic Wills – Angela M. Adams, Chair

Angela provided the following potential committee motion for future consideration:

(A) Support proposed legislation which would amend §117.201, Fla. Stat., to create a definition of "witness" (when used as a noun) for purposes of remote online notarization and witnessing of electronic documents.

(B) Find that such legislative position is within the purview of the RPPTL Section; and

(C) Expend Section funds in support of the proposed legislative position.

# **2. Guardianship Law Revision Committee –** *Nick Curley, Stacey Rubel, David Brenna, Co-Charis*

Stacey Rubel updated the status of the guardianship code revision. She prefaced her remarks by stating that the previously unanimously approved minutes of the Breakers July 24, 2021 meeting were erroneous because her recollection was that the Probate and Trust Division had received a loud round of applause and people were waiving napkins. Ms. Rubel was ruled out of order and the previously unanimously approved minutes stand.

#### XII. General Standing Division Report — Sarah S. Butters, Chair-Elect

#### Action Items:

#### **1.** Fellows – Chris Sajdera, Chair

The RPPTL Fellows is a two-year program that encourages the involvement of attorneys from diverse backgrounds that are traditionally underrepresented in the law and the Section. One of the main benefits of the Fellows program is the dialog and professional relationship development that occurs during the activities of the in-person meetings. Currently, Fellows are each allocated \$2,500 per year to defray the costs of attendance at the instate meetings. Due to COVID, many hotel and travel expenses have increased, making the stipend insufficient. Accordingly, the Fellows Committee is seeking a stipend increase as follows:

# (A) Motion to increase each Fellow's stipend by \$500 per year, from the current \$2,500 to \$3,000 annually, effective for Fellows as of the 2021-2022 bar year.

Since the Motion comes from a committee, it required no second.

The Motion was approved unanimously.

As part of the Section's Strategic Plan, the goals and description of the Fellows program was reviewed with an eye towards highlighting participation and involvement by Fellows. In furtherance of that goal, the Fellows committee undertook a review of their mission statement and long-term goals, and propose the following revisions to the Mission Statement.

Mission Statement:

The RPPTL Section of the Florida Bar encourages involvement of attorneys from diverse backgrounds, including geographic, racial and ethnic backgrounds that are traditionally underrepresented in the law and the Section. The mission of the RPPTL Fellows program is to recruit attorneys who have a demonstrated interest in practicing in the area of wills, trusts, estates, and/or real estate, and who are interested in greater involvement in the RPPTL Section and its committees, but who would not otherwise be able to participate due to financial constraints or needs. Our goal is to provide opportunities for deserving attorneys to achieve their career goals through leadership training and working closely with leading attorneys in their field, while at the same time, fostering diversity within the Section, The Fellowship Program is open to all lawyers who are members of the RPPTL Section, and who have been admitted to the Bar for at least 3 years and for fewer than 12 years.

#### (B) Motion to approve the revised Mission Statement.

Since the Motion comes from a committee, it required no second.

The Motion was approved unanimously.

#### Information Items:

#### 1. Liaison with Clerks of the Court – Laird A. Lile

Laird introduced Linda Doggett (Lee County Clerk of Circuit Court & 127630256.2

Comptroller) and Kevin Karnes (Chief Operating Officer, Lee County Clerk of the Courts). Linda thanked the Section for the support of the Clerk. Kevin spoke about a recent 1<sup>st</sup> DCA decision regarding the recording of documents, and about e-certified records in Lee County. He noted that Lee County is always looking to be more efficient through technology and otherwise. He also welcomed any suggestions from the Section.

#### 2. Liaison with TFB Pro Bono committee – Lorna Brown-Burton

Lorna Brown-Burton noted that she is running for President of the Florida Bar.

Lorna commented that at the Pro Bono Committee meeting at The Florida Bar's Fall meeting the following was discussed:

- Overall, 38,989 individual attorneys reported providing 1,505,042 hours of pro bono work, and another 574 attorneys said they provided 22,970 hours through law firm pro bono plans. Another 25,054 lawyers said they contributed \$6.7 million to legal aid organizations. This was from July 1, 2020 – June 30, 2021.
- Lorna stated that Chair Kathy McLeroy noted the committee is planning a pro bono summit at the Bar's next Annual Convention. A subcommittee was created to begin planning the Pro Bono Summit.
- The Florida Bar Foundation, with committee support, is restarting the One Promise campaign to encourage pro bono volunteers. The Foundation has received funds from donations to create several videos targeting different groups to promote pro bono.

#### 3. Law School Programming Committee – Johnathan Butler, Chair

Johnathan Butler gave his report by Zoom. He noted that there would be a guardianship zoom presentation on November 13, 2021.

Johnathan also reported that the committee liaisons have been busy at the law schools this summer and fall. For example, Rebecca Wood, University of Florida liaison, coordinated a bike ride on Friday September 3<sup>rd</sup> with Professor Dayana Wright and some of the UF law students. Then, on Wednesday, October 20<sup>th</sup>, Rebecca recruited Gainesville attorney Patrice Boys to speak to UF law students and other law students via Zoom about her practice in Environmental and Land Use Law.

On Friday, October 15<sup>th</sup> the Stetson liaison, Rebecca Bell, chaired "A Day In the Life of a Lawyer" via Zoom with fellow At Large Members (ALMs) and Section members Rachel Oliver, Kip Thornton and Kit Van Pelt speaking about their particular practices, niches and how each lawyer made it along her/his career path.

Nova liaisons Kym Curry-Smith and Sandy Boisrond worked closely with Nova law student leaders in a "Free Britney" Conservatorship and Guardianship zoom panel over two dates, Friday October 29<sup>th</sup> and Friday November 12<sup>th</sup>.

Mock interviews were held virtually at University of Miami in August with RPPTL committee liaison Liz Hughes' recruiting RPPTL volunteers. Mock interview co-chairs Phil Baumann and Guy Emerich continue to work closely with the law school liaisons to resume mock interviews in Fall 2021 and Spring 2022, at least by Zoom or in person where possible.

Ahead of the Tallahassee RPPTL meeting scheduled for March 30 – April 2, 2022, the Committee is coordinating a mixer/social with FSU law students, Section members and a few local judiciary on Wednesday March 30<sup>th</sup>. More details to follow.

#### 4. Fellows – Chris Sajdera, Chair

No report was given.

Sarah called the Fellows in the room and on Zoom to introduce themselves, which they did.

#### 5. **Professionalism & Ethics Committee** – Andrew B. Sasso, Chair

Oshi Smith gave the report and played a podcast from the RPPTL Professionalism and Ethics Committee Podcast. The title of the podcast was Overlooked and Misunderstood Ethical Issues.

In the podcast, Judge Nelly Khouzam spoke about *Andreaus v. Impact Pest Management, Inc.,* 157 So.3d 442 (Fla. 2d DCA 2015) in the context of Ethical Rule 4-3.3 and 4-3.4.

#### 6. Ad Hoc Revocable Transfer on Death Committee – Christopher Smart and Stephen Kotler, Co-Chairs

Chris Smart reported that the Committee is working hard and hopes to have proposed legislation next year.

#### XIII. Adjourn: Motion to Adjourn was made and passed unanimously.

(B) Find that such legislative position is within the purview of the RPPTL Section; and

(C) Expend Section funds in support of the proposed legislative position.
