Timeline

Before getting to the particulars, here is a graphic timeline of the VERY IMPORTANT DEADLINES that you need to know about for purposes of registering for the EC meeting events and then making your hotel reservation:

Sept. 20

Deadline to cancel or modify room reservation without penalty.

Oct.

- 1) Last day to fully cancel your hotel reservation with only one night deposit penalty. After this date, any cancellations will forfeit the full deposit.
- 2) Last day to modify room reservation (reduction of night) with only \$150 penalty. After this date, any modifications will result in a one night deposit penalty.

Oct. 25

Advance registration closes.

Hotel Reservation Instructions

Once you have registered for the Executive Council meeting events, please follow the instructions on the Bar website to be able to click on the link to make your hotel reservation. This is a different procedure than the last meeting - you will not receive an email to reserve your hotel room. NO TELEPHONE RESERVATIONS WILL BE ACCEPTED. Please do not make a hotel reservation UNLESS YOU FULLY ANTICIPATE THAT YOU WILL BE ATTENDING THE MEETINGS!

Here are particulars and information that you need to know:

- 1. Your access through the Bar website to the hotel webpage is designed for one use only. If you send this information to others and they make a reservation, your friends' reservations will be cancelled.
- 2. You will only be able to book one room.
- 3. When you make your reservation, the hotel will be taking an advanced deposit of two nights.
- 4. September 20th is the DROP-DEAD, ABSOLUTE deadline for canceling or modifying your hotel reservation without penalty.
- 5. After September 20th, if you WHOLLY CANCEL YOUR HOTEL RESERVATION, you will forfeit ½ of your deposit (one night) if cancellation occurs prior to or on October 2nd. If you cancel after October 2nd, you will forfeit all of your deposit (two nights).
- 6. After September 20th, if you MODIFY YOUR HOTEL RESERVATION (i.e. shorten your stay), you will forfeit \$150.00 from your deposit. If you make modifications after October 2nd, you will forfeit ½ of your deposit (one night). This is necessary because shortening of stays has a definite impact on our room block and each year we consistently have to juggle the room block because of late modifications.
- 7. TO CANCEL OR MODIFY A RESERVATION, YOU (NOT YOUR ASSISTANT!) MUST EMAIL MARY ANN OBOS AT MOBOS@FLORIDABAR.ORG WITH YOUR REQUEST (NO TELEPHONE CALLS OR VOICE MESSAGES WILL BE ACCEPTED!). YOU CANNOT CANCEL OR MODIFY YOUR RESERVATION BY CALLING THE HOTEL.
- 8. If the room block is full by the time you try to make your hotel reservation, DON'T PANIC put your name on the waitlist, which is being monitored throughout the entire process. The plan is that with this reservation procedure, we will have fewer people on the waitlist, and with cancellations and modifications, we should be able to get the vast majority, if not all, of those who are on the waitlist into a room at the hotel.

Please do not call, or have your assistant call, Mary Ann (or Hilary) to check on the status of when the registration and hotel reservation process will open or the status of the waitlist. We will communicate promptly with those on the waitlist as rooms become available.
