Welcome to the Breakers! It is always great to kick off our meeting at the Breakers by spending time with old and new friends at our Welcome Reception. Join us in the Venetian Ballroom for our traditional heavy hors-d'oeuvres (really, it's dinner, right?) along with excellent wines and beer. After the Reception, Hospitality will take place in the Circle Dining Room, where we will have some desserts that our group has never had before at the Breakers!

Timeline

Before getting to the particulars, here is a graphic timeline of the VERY IMPORTANT DEADLINES that you need to know about for purposes of registering for the EC meeting events and then making your hotel reservation:

June 13 Deadline to cancel or modify room reservation without penalty

July 3

- 1) Last day to fully cancel your hotel reservation with only one night deposit penalty.
- 2) Last day to modify room reservation (reduction of night) with only \$150 penalty.

July 13

- 1) Cancellation after this date is the full deposit penalty.
- 2) Modification of room reservation (reduction of night) after this date is one night penalty.

Hotel Reservation Instructions

Once you have registered for the meeting events, you will receive an e-mail with a link to make your hotel reservation at the Breakers. NO TELEPHONE RESERVATIONS WILL BE ACCEPTED. Please do not make a hotel reservation UNLESS YOU FULLY ANTICIPATE THAT YOU WILL BE ATTENDING THE MEETINGS!

Here are particulars and information that you need to know:

- 1. The hotel reservation link that you will receive is designed for one use only. If you send this link to others and they make their reservation before you, you will NOT be able to make a hotel reservation.
- 2. You will only be able to book one room, as has been the custom for several years. Several of you have asked whether you can book multiple rooms for your family the answer is unfortunately no, as we only have a limited number of rooms allocated by the Breakers in our room block.
- 3. When you make your reservation, the Breakers will be taking an advanced deposit of two nights this is different from the past, where only one night's deposit was taken. This has become necessary in order to manage cancellations as noted in the timeline and as discussed below.
- 4. June 13th is the DROP-DEAD, ABSOLUTE deadline for canceling or modifying your hotel reservation without penalty.
- 5. After June 13th, if you WHOLLY CANCEL YOUR HOTEL RESERVATION, you will forfeit ½ of your deposit (one night) if cancellation occurs prior to or on July 3rd. If you cancel after July 3rd, you will forfeit all of your deposit (two nights).
- 6. After June 13th, if you MODIFY YOUR HOTEL RESERVATION (i.e. shorten your stay), you will forfeit \$150.00 from your deposit if you do so prior to or on July 3rd. If you make modifications after July 3rd, you will forfeit ½ of your deposit (one night). This is necessary because shortening of stays has a definite impact on our room block and each year we consistently have to juggle the room block because of late modifications.
- 7. To cancel or modify a reservation, you MUST email Mary Ann Obos at mobos@floridabar.org. DO NOT CALL BREAKERS OR BAR STAFF- ALL REQUESTS MUST BE IN WRITING VIA EMAIL.
- 8. If the room block is full by the time you try to make your hotel reservation, DON'T PANIC put your name on the waitlist, which is being monitored throughout the entire process. The plan is that with this new reservation procedure, we will have fewer people on the waitlist, and with cancellations and modifications, we should be able to get the vast majority, if not all, of those who are on the waitlist into a room at the Breakers.



Did you know?

If we do not meet our minimum hotel room block requirements due to room cancellations and modifications, the Section gets charged large penalties. Cancelling or modifying reservations at the last minute prevents people on the waitlist from having the opportunity to stay at the hotel and can cost the RPPTL Section thousands of dollars!
